FULL POSITION DESCRIPTION

DUTIES

- A. Provide operational, management and coaching leadership for the relevant state team, which may include assisting in the organisation of the team tour, the organisation of trials, selection of students, coaching and preparation of team, and organising relevant documentation for team members.
- B. Undertake selection of players according to Team Vic policy and procedure and provide selection feedback to players.
- C. Undertake the management and/or coaching duties as required prior to, during and after the conduct of the 2022 & 2023 School Sport Australia Championships.
- D. Collaborate with SSV staff, SSA officials and other Team Vic officials
- E. Undertake any other duties as required by SSV in relation to the state / interstate program in that sport.

QUALIFICATIONS

- Coach/Assistant Coach must hold a current National Coaching Accreditation Scheme (NCAS) or similar in the relevant sport (minimum Level 1).
- Managers/Tour Managers must hold current First Aid qualifications.
- Sports Trainers must hold a current Sports Trainers accreditation or similar.
- Teachers must hold a current VIT registration.
- Non-Teachers must hold a current Working with Children (WWC) accreditation.

KEY SELECTION CRITERIA

- Criteria 1: 'Victorian Public Sector Values' as detailed in Organisational Values section above.
- Criteria 2: Demonstrated ability to work as part of a multi-disciplinary team.
- Criteria 3: Demonstrated management / coaching in the particular sport at a school / community or higher level.
- Criteria 4: Demonstrated leadership in the management and coaching of student athletes.
- Criteria 5: Demonstrated knowledge of the rules and regulations of the School Sport Australia Championships.

OTHER RELEVANT INFORMATION

- Team Vic is the name given to State Teams representing SSV.
- The Department of Education and Training (DET) has duty of care responsibility for all students, teachers, team officials attending School Sport Australia Championships.
- All officials are required to commit to the School Sport Australia Codes of Behaviour and the SSV policies and procedures relating to state teams.
- The selection panel reserves the right to seek information about the applicant outside the nominated referees and prior knowledge of applicants will be a factor in the selection process.
- Selection of team officials is subject to Principal approval for teachers
- The management / coaching group must include at least one teacher.
- Replacement teacher funds for schools are available for all SSV appointments.







HOW TO APPLY

- Complete the online registration form which includes the submission of your CV, responses to the Key Selection Criteria (maximum 3 additional pages) and evidence of your qualifications.
- Two referees must be nominated on the application form. (Teachers are required to discuss this with their school principal nominate the principal as part of the application process).
- Applications will be automatically submitted from the online registration form.
