- 5. A student who is under 18 years of age must have the consent of a parent/guardian to enter into this Competition.
- 6. No responsibility can be accepted for entries not received for whatever reason.
- 7. SSV reserves the right to disqualify any student it finds to be acting in breach of these T&Cs.
- 8. SSV reserves the right to cancel or amend the Competition and these T&Cs without notice. Any changes to the Competition will be notified to entrants as soon as possible by SSV via the SSV website.
